NYSIM and Kaplan Team-Up to host Procedures Preparation and Assessment Workshop

NYSIM hosted a 2-day procedure workshop taught by Drs. Brad Green and Demian Szyld for 10 students. This 2-day workshop served as a pilot program for a larger, recurring program and was comprised of 18 fundamental procedural skills necessary to prepare students for American Board of Internal Medicine certification in internal medicine.



Students were asked to review a preparation handbook and spent 2 days practicing procedures including: informed consent, ultrasound guided procedures, pelvic exam and pap smear, lumbar puncture, thoracentesis, and direct/video laryngoscopy. In the larger program students will have the opportunity to also participate in a half day ACLS course.

NYSIM is looking forward to developing its relationship with Kaplan on other initiatives.
