Workshop 2:00PM – 4:00PM – Society for Simulation in Healthcare Accreditation: A Roadmap to Success

Simulation centers provide a specialized service where quality patient is critical to maintaining the success of services. In this session, the drivers for SSH accreditation, issues from experienced simulation centers, and common areas for improvement in the field will be discussed. SSH Accreditation, policies & procedures, and the accreditation standards will be briefly reviewed, provided, and the intent behind standards discussed as a guiding roadmap to programmatic success.

Grand Rounds 5:00PM – 6:00PM - We Need to Talk. Simulation-Enhanced Interprofessional Education

We have come to understand why interprofessional education (IPE) is important to healthcare. Healthcare simulation is increasingly the preferred platform for IPE for many reasons. How can we develop interprofessional learning activities using simulation? Simulations can be designed for any level of learning. This session will discuss the why anyhow of IPE utilizing healthcare simulation, the difficulties educators and organizations face in this effort, salient questions that the field is currently struggling to understand and tips in overcoming these issues.



Biography—Dr. Janice Palaganas

Janice Palaganas, PhD, RN, NP is the Associate Director of the Institute for Medical Simulation in Boston, Massachusetts – the most renowned program for interprofessional simulation educator training. Dr. Palaganas is a recognized leader and expert in the field of simulation as Principal Faculty for the Center for Medical Simulation, the implementing director of the Society for Simulation in Healthcare's (SSH) Accreditation (of simulation centers) and Certification (of simulation educators) Program, the Editor-in-Chief of SSH's first resource textbook (71 chapters, 138 authors), Chair of the 2011 Simulation and IPE Symposium, and first Chair of the SSH IPE Affinity Group. As a behavioral scientist, Dr. Palaganas' passion is in using healthcare simulation as a platform for IPE –the concentration of her doctoral studies. Dr. Palaganas' primary role is to develop simulation educators in an IPE setting. She has presented at conferences regarding projects in simulation and interprofessional education. She has been an invited keynote speaker to discuss interprofessional education, simulation, patient safety, and accreditation, and sits as a member of the Measuring the Impact of IPE Committee for the Institute of Medicine (IOM). Dr. Palaganas is also an author for the National League for Nursing (NLN) study for high-stakes assessment using simulation for nursing students and authored and evaluated the challenges of assessing teamwork in students using simulation.

Dr. Palaganas received her Bachelor's of Science in Nursing, as well as two Masters degrees as an Adult Nurse Practitioner and Geriatric Nurse Practitioner; one Masters certificate in Home Health Management from the University of Pennsylvania, and her PhD in Nursing at Loma Linda University exploring healthcare simulation as a platform for inter-professional education.

Clinically, Dr. Palaganas has held multiple roles in Emergency Departments in ranging from Research Assistant, Emergency Clinical Staff Nurse, Fast Track Nurse Practitioner, Educator Specialist, Trauma Nurse Practitioner, Emergency Department Manager to Director of Emergency and Critical Care Services of a multi-hospital system. She has also worked as a Legal Nurse Consultant, as well as Hospital House Supervisor. She is experienced in hospital and university management with ten years of hospital (Director of Emergency and Critical Care Services of a three hospital system) and university (Simulation Department COO and Director of Research) management experience and has served on the Board of Examiners for the Malcolm Baldrige National Quality Award under the National Institute of Standards and Technology. Additionally, Dr. Palaganas has taught for schools of medicine, nursing, pharmacy, allied health, business, religion, and emergency residency, and is experienced in providing simulation-enhanced IPE to multiple levels of pre- and post-licensure learners.
